Under certain circumstances, the awarded project may be transferred to a new location with the awarded recipient.

The application **must be signed by both the applicant and the school principal or school coordinator**. A request without both signatures will not be accepted. In accepting this grant, we ask that you read the requirements as outlined below and indicate your agreement by your signatures.

- We agree that any member of the Foundation may call upon me at any time during the course of the project to evaluate its progress.
